Change of Applicable European Standard from EN 60950 to EN 62314 on Selected SSR Product Families

Scope:

Recently there was a change in the applicable EN standard under which some of our SSR products are certified by VDE. As the new standard (EN 62314) supersedes the old standard (EN 60950), we are taking this opportunity to change our certification agency to TUV.

Description of Changes:

Parts manufactured as of December 21st, 2020 will be certified under EN 62314 and carry the TUV marking.

None of the other agency certifications applicable to such products (UL, CSA, etc.) will be affected, and there will be no changes on the actual product, other than the marking.
